TRAUMA COACHING

Toshia Shaw is a survivor of chronic trauma. After having survived she became engrossed with the various paths to healing. She found clinical therapy, holistic, and energy healing to be effective and she emerged trauma-free and healed.

WHAT IS TRAUMA COACHING?

Remember and telling the truth are prerequisites for healing. The conflict between the will to deny horrible events and the will to proclaim them aloud is the central dialectic of psychological trauma. People who have survived atrocities often depend on secrecy, and the ability to bury the truth to try and live a somewhat "normalized" life. When the survivor is able to tell the story of the traumatic event that is when survivors can begin their recovery. Traumatic coaching is the ability to help the survivor recognize the truth, speak up about it, and begin their road to healing.

Trauma coaching helps people: to remove the blocks that prevent them from truly living. Toshia provides compassionate and trauma informed life-coaching, to gently help you heal from your past.

GOAL OF TRAUMA COACHING?

The trauma coach provides a safe and sacred setting. Toshia remains open, receptive, compassionate and non-judgmental, supporting each client to look within, to recognize one's true nature.

CONFIDENTIALITY

All information discussed in each session is confidential with three exceptions: (1) when a client poses a danger to themselves or others, (2) when requested by a court of law, or (3) for purposes of professional supervision (in which case, your name and identifying information will not be used).

Please be advised that disclosure of child abuse or suicide attempts must be reported by law.

FEE STRUCTURE

Full payment is due at the time of each session. NOTE: During the intervening time between sessions I am available for 1 or 2 brief (10-15 minute) telephone conferences or by email. Couples are expected to call simultaneously.

CONFIDENTIALITY

All cancellations require a 24-hour advance notification, and payment can be used towards future appointments. There are no refunds. Ten minutes grace into the appointment. After the ten minutes there is not enough time for a session. Client is responsible for full fee for missed or late session. Clients who are within the ten-minute grace period will be seen for the remainder of the 50-minute session, not to extend past the allotted time. **If the appointment is in NV, and it is missed, then a room rental fee reimbursement is required.**
